Corrections to the March minutes were offered by M. Watts

March minutes were approved with corrections.

## **Program Update (M. Watts)**

Program assistant position has been posted for five weeks with zero applicants. There is a labor shortage and salary is low. The position was posted at the bottom of the approved salary range (\$14). Mary is working with HR to rewrite description to get it coded as higher ranking position.

Basic training for 2022 is complete. It really went well.

Jennifer Marques has been working on creating an endowed faculty chair position. To do this \$1.5 million will need to be raised. This role will put together training for recruits state wide. We will be hearing more during next year's 50th year anniversary commemorations. Jennifer is currently estimating that it will be five years before we have enough money to hire the person. This position will be fully dedicated to Master Gardener program.

Clinics launched this last weekend. Things are starting to feel more normal. Some email about one or more clinics wanting to use tablets. Also possibly having internet access for those. Gabby Hong became the leader of the Garden Leadership Team in May.

### Finance Policy (Jim)
